

SCANSOURCE COMMUNICATIONS & POLYCOM Q2 2009-Q1 2010 SWEEPSTAKES

Official Rules

SCANSOURCE COMMUNICATIONS, INC.'S AND POLYCOM, INC.'S HOME SUITE HOME (THE "SWEEPSTAKES") IS OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, AND CANADA (EXCEPT THE PROVINCE OF QUEBEC) WHO AT THE TIME OF ENTRY ARE: (1) 21 YEARS OF AGE OR OLDER; (2) REGISTERED RESELLERS, INTEGRATORS OR SERVICE PROVIDERS OF SCANSOURCE COMMUNICATIONS, INC. OR CATALYST TELECOM (COLLECTIVELY "SCANSOURCE"); AND (3) IN GOOD FINANCIAL STANDING WITH SCANSOURCE. THE SWEEPSTAKES IS ALSO OPEN TO BUSINESS ENTITIES DOMICILED IN THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA AND CANADA (EXCEPT THE PROVINCE OF QUEBEC) WHICH AT THE TIME OF ENTRY ARE REGISTERED RESELLERS, INTEGRATORS OR SERVICE PROVIDERS OF SCANSOURCE AND ARE IN GOOD FINANCIAL STANDING WITH SCANSOURCE. DIRECT MARKETERS ("DMARs"), DISTRIBUTORS, MANUFACTURERS AND OTHER COMPETITORS OF SCANSOURCE, AS THOSE TERMS ARE DEFINED OR INTERPRETED BY SCANSOURCE IN ITS SOLE DISCRETION, ARE NOT ELIGIBLE TO PARTICIPATE IN THE SWEEPSTAKES.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, U.S. TERRITORIES AND POSSESSIONS, THE PROVINCE OF QUEBEC AND WHERE PROHIBITED OR RESTRICTED BY LAW.

1. SWEEPSTAKES PERIOD:

The Sweepstakes begins April 1, 2009 at 12:00:01 a.m. (EST) and ends March 31, 2010 at 11:59:59 p.m. (PT) (the "Sweepstakes Period").

2. HOW TO ENTER:

Eligible Participants must register for the Sweepstakes by completing the Sweepstakes registration form available at www.homesuitehomepromo.com. All required information on the registration form must be fully completed and only one (1) registration will be accepted per person/business entity. After registering, Eligible Participants may enter the Sweepstakes in either of the following two ways:

(A) Eligible Participants who purchase any Polycom products from ScanSource during the Sweepstakes Period are automatically entered in the Sweepstakes. Such Eligible Participants may earn entries into the various Sweepstakes prize drawings as described in Section 3, below.

(B) To enter the Sweepstakes without purchasing qualifying products, hand-print name, address, city, state, zip, day and evening phone numbers and the words “Home Sweet Home Sweepstakes” on a 3"x 5" card, and mail in a stamped envelope to: “Home Sweet Home Sweepstakes” ScanSource Communications, Inc., 6 Logue Court, Greenville, SC 29615. Mail-in entries for the Sweepstakes quarterly and grand prize drawings must be actually received by ScanSource by the day prior to the date of each such drawing. Non-winning entries for a quarterly prize drawing will not be carried over to subsequent quarterly prize drawings. Participants may enter as often as they wish; however, only one mail-in entry per stamped envelope will be accepted. No copies or mechanical reproductions of entries will be accepted. Neither Sponsors nor any of their employees, representatives or agencies, are responsible for lost, late, damaged, delayed, destroyed, misdirected, postage-due, incomplete, or illegible entries. Entrants need not be present to win. Once submitted, entries become the exclusive property of Sponsors and will not be returned.

3. ELIGIBILITY:

The Sweepstakes is open only to legal residents of the 50 United States and the District of Columbia and Canada (except the province of Quebec), who at time of entry are: (i) 21 years of age or older; (ii) are registered resellers, integrators or service providers of ScanSource; and (iii) in good financial standing with ScanSource. The Sweepstakes is also open to business entities domiciled in the 50 United States and the District of Columbia and Canada (except the province of Quebec) which at time of entry, are registered resellers, integrators or service providers of ScanSource and are in good financial standing with ScanSource. DMARs, distributors, manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes. Employees of ScanSource and Polycom and their parents, affiliates, subsidiaries, and other affiliated companies, agents, advertising and promotional agencies, and their immediate family members or persons residing in the same household of such employees, are not eligible to enter or win.

4. SELECTION OF WINNERS/ODDS OF WINNING PRIZE:

Quarterly Prize Drawings

There will be two (2) separate prize drawings each quarter during the Sweepstakes Period.

First Quarterly Prize Drawing

Four (4) quarterly prize drawings will be held on or about July 13th, 2009, October 12th, 2009 January 11th, 2010 and April 12th, 2010 in Greenville, South Carolina from among the Eligible Participants who, before the date of each such quarterly prize drawing (1) have satisfied the

requirements for entry set forth in Section 2(A), above, and earned at least one (1) entry into the random prize drawing as described below; **or** (2) satisfied the requirements for entry set forth in Section 2(B), above. One (1) Eligible Participant will be selected from each such quarterly prize drawing to receive the quarterly prize described in Section 5, below.

Eligible Participants who have satisfied the requirements for entry set forth in Section 2(A), above, may earn entries into these random prize drawings as follows:

- ∞ Eligible Participants receive one (1) entry into a drawing if they purchase at least Thirty Thousand and 00/100 Dollars (\$30,000) of Polycom products from ScanSource in the applicable quarter and their purchases of Polycom products from ScanSource in the applicable quarter represent at least a ten percent (10%) increase (measured by dollar value) over their Polycom product purchases from ScanSource in the prior quarter. Eligible Participants receive one (1) additional entry into the drawing for every additional one percent (1%) increase in their purchases of Polycom products from ScanSource in the applicable quarter relative to their purchases in the prior quarter. By way of example, an Eligible Participant who purchases at least \$30,000 of Polycom products from ScanSource in a given quarter during the Sweepstakes Period and also increases its purchases of Polycom products from ScanSource by eleven percent (11%) in that quarter relative to its prior quarter purchases will receive two (2) entries into the applicable drawing. By way of further example, an Eligible Participant who purchases at least \$30,000 of Polycom products from ScanSource in a given quarter during the Sweepstakes Period and also increases its purchases of Polycom products from ScanSource by twelve percent (12%) in that quarter relative to its prior quarter purchases will receive three (3) entries into the applicable drawing.

Second Quarterly Prize Drawing

Four (4) quarterly prize drawings will be held on or about July 13th, 2009, October 12th, 2009, January 11th, 2010, and April 12th, 2010 in Greenville, South Carolina from among the Eligible Participants who, before the date of each such quarterly prize drawing: (1) have satisfied the requirements for entry set forth in Section 2(A), above, and earned at least one (1) entry into the random prize drawing as described below; **or** (2) satisfied the requirements for entry set forth in Section 2(B), above. One (1) Eligible Participant will be selected from each such quarterly prize drawing to receive the quarterly prize described in Section 5, below.

Eligible Participants who have satisfied the requirements for entry set forth in Section 2(A), above, may earn entries into these random prize drawings as follows:

- ∞ Eligible Participants will receive a certain number of entries into the applicable drawing (as determined by Sponsors in their sole discretion) for purchases of Polycom product designated by ScanSource as feature products for the applicable quarter. Information regarding the feature products for each quarter of the Sweepstakes and the number of

purchases of such products necessary to gain a single entry into the drawing for that quarter will be available on the Sweepstakes website at least three (3) days prior to the beginning of the applicable quarter. For the quarter beginning April 1, 2009, for every twenty (20) purchases of the featured Polycom voice product Eligible Participants will receive one (1) entry into the drawing applicable to that quarter and for every purchase of one (1) featured Polycom video product for that quarter Eligible Participants will receive one (1) entry into the drawing applicable to that quarter. By way of example, if an Eligible Participant purchases forty (40) featured Polycom voice products and five (5) featured Polycom video products from ScanSource during the quarter beginning April 1, 2009, that Eligible Participant will earn seven (7) entries into the drawing applicable to that quarter.

Grand Prize Drawing

One (1) grand prize drawing will be held on or about April 5, 2010 in Greenville, South Carolina from among the Eligible Participants who, before the date of the grand prize drawing (1) have satisfied the requirements for entry set forth in Section 2(A), above, and earned at least one (1) entry into the grand prize drawing as described below; **or** (2) satisfied the requirements for entry set forth in Section 2(B), above. One (1) Eligible Participant will be selected from the grand prize drawing to receive the grand prize described in Section 5, below.

Eligible Participants who have satisfied the requirements for entry set forth in Section 2(A), above, may earn entries into the random prize drawings as follows:

- ∞ Eligible Participants receive one (1) entry into the drawing if they purchase at least Thirty Thousand and 00/100 Dollars (\$30,000) of Polycom products from ScanSource during each quarter of the Sweepstakes Period and their purchases of Polycom products from ScanSource increased in each such quarter (e.g., the Eligible Participant purchased more Polycom products from ScanSource in the second quarter of 2009 than it did in the prior quarter, more in the third quarter than the second quarter, and more in the fourth quarter than the third quarter). Eligible Participants receive one (1) additional entry into the drawing for every additional one percent (1%) increase in their purchases of Polycom products from ScanSource in a given quarter during the Sweepstakes Period relative to their purchases in the prior quarter. By way of example, an Eligible Participant who meets the requirements to receive one (1) entry into the Sweepstakes (\$30,000 in Polycom purchases each quarter and purchase increases each quarter during the Sweepstakes Period) and whose second quarter purchases of Polycom products from ScanSource increases by one percent (1%) over the prior quarter, whose third quarter purchases increase by three percent (3%) over the second quarter, and whose fourth quarter purchases increase by five percent (5%) of the third quarter, will receive ten (10) entries into the grand prize drawing.

Skill-Testing Question for Canadian Residents: If a selected potential winner is a Canadian resident, in order to win the prize, the Canadian resident must first correctly answer unaided a time-limited, mathematical skill-testing question by telephone at a predetermined mutually agreeable time. In the event that the selected Canadian resident is unable to correctly answer the skill-testing question, Canadian resident will forfeit prize, and Sponsors will have the right to randomly draw another eligible potential winner.

Limit one (1) quarterly prize per person/business entity per quarterly prize drawing (i.e., an Eligible Participant may only receive one (1) prize from each First, Second and Third Quarterly Prize Drawing). Odds of winning each quarterly prize drawing depends on the total number of eligible entries received as of the appropriate cut-off date for such quarterly drawing. Odds of winning the Grand Prize depend on the number of eligible entries received. Participants agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects. Winners will be notified by e-mail, telephone, or facsimile. The authorized officer(s) of a winning business entity may designate an individual recipient of the prize by specifying such individual in writing prior to acceptance of the prize.

Winners must comply with all of the terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Winner(s) may be required to sign and return an Affidavit of Eligibility and Release within 14 days of notification in order to receive the prize(s). Travel companions must be at least 18 years of age. Travel companions will be required to sign and return a liability release not less than 14 days before departure date or will not be permitted to accompany winner on trip. In the event of non-compliance with these requirements, the prize will be forfeited and an alternate winner will be selected. If prize/prize notification is returned as undeliverable, the prize will be forfeited and an alternate winner will be selected. Unclaimed prizes may not be awarded.

In the event of a dispute as to the identity of a winner based on an e-mail address, the winning entry will be deemed to be the authorized account holder of the e-mail address submitted at time of entry. For purposes hereof, an "authorized account holder" is the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

5. PRIZES:

Grand Prize

Sponsors will award one (1) Sweepstakes Grand Prize consisting of: (i) Ten Thousand and 00/100 Dollars (\$10,000) worth of Polycom demonstration equipment selected by Sponsors (Average Retail Value: \$10,000); and (ii) a "Dream Polycom Week" consisting of a three (3) day visit by Polycom and ScanSource management to the grand prize winner's designated office

location for comprehensive marketing, sales and technical training and other activities designed to enhance the grand prize winner's business (Average Retail Value: \$10,000).

Quarterly Prizes

Sponsors will award eight (8) quarterly prizes (one (1) for each First and Second Quarterly Prize Drawing) consisting of: (i) Three Thousand Five Hundred and 00/100 Dollars (\$3,500) in marketing dollars to be used toward the purchase of ScanSource marketing services; and (ii) a trip for two (2) employees of the winner to ScanSource's Greenville, South Carolina headquarters for two days and 1 night for a "Company Improvement Day" during which the winner's employees will meet with various ScanSource management and professional personnel to discuss ways the winner's business may be enhanced. (Average Retail Value: \$5,000.00). (Actual value may vary based on airfare fluctuations and distance between departure and destination). Each trip includes round-trip, coach-class air transportation from the closest major airport to the winner's home address (determined by Sponsors in their sole discretion); two (2) rooms standard hotel accommodations for 2 (double occupancy) for 2 days/1 night. Exact travel dates, car rental, and hotel accommodations subject to availability and blackout dates.

Prizes are non-transferable. All taxes or expenses, including, without limitation, meals, gratuities, transportation costs, transportation to and from airport, sales tax, luxury tax and any other costs incurred in claiming or using any of the prizes, are the sole responsibility of the prize winner. No prize substitution or cash equivalent of prize, except at Sponsors' sole discretion, and then only for a prize of equal or greater value. Any difference between the actual value of any prize and the approximate retail value set forth in these Official Rules may not be claimed and will not be awarded.

6. GENERAL CONDITIONS:

(a) This Sweepstakes is subject to all federal, state and local laws and regulations. The laws of the United States of America shall be deemed to govern the Sweepstakes.

(b) Acceptance of prize shall constitute and signify the winner's agreement and consent that Sponsors may use his/her name address (city and state only), likeness, and/or prize information for promotional purposes without further compensation, where legal (Tennessee residents and residents of Canada need not consent to, or sign any, publicity release.)

(c) Participants, by participating, release and agree to hold harmless Sponsors and their parents, affiliates, subsidiary companies, advertising and promotion agencies and their respective directors, officers, employees, representatives and agents from any and all liability for any injuries, losses, tax liabilities or damages of any kind to person, including death, and property, arising in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any prize, participation in any Sweepstakes related activity, or participation in the Sweepstakes.

(d) Sponsor and its parents, affiliates, subsidiary companies, advertising and promotion agencies and contest administrators and their respective directors, officers, employees, representatives and agents are not responsible for any typographical or other error in the printing

of the Sweepstakes, administration of the Sweepstakes or in the announcement of the prizes. Sponsor reserves the right to modify the Sweepstakes rules, terms and conditions without materially affecting the terms and conditions of the Sweepstakes.

(e) Except where prohibited, participants agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes, or any prize awarded, or the determination of the winner(s) shall be resolved individually, without resort to any form of class action, and exclusively under the laws of the State of South Carolina and through the courts of Greenville County, South Carolina; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes but in no event attorneys' fees; and (3) under no circumstances will participants be permitted to obtain awards for and participants hereby waive all rights to claim punitive damages, incidental damages, consequential damages or any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

Without limiting the foregoing, all prizes are provided "as is" without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose, or non-infringement.

(f) If for any reason the Sweepstakes is not capable of running as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. In such event, Sponsor may award prizes in a random drawing from all eligible entries received up to the date of cancellation or suspension.

(g) Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, registrations or entries. Sponsor is not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any registration, e-mail or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any Web site, or any combination thereof, including any injury or damage to a participant's or any other person's computer relating to or resulting from participation in the Sweepstakes or downloading any materials in the Sweepstakes.

(h) **WARNING: ANY ATTEMPT BY A PARTICIPANT OR ANY OTHER PERSON TO DELIBERATELY DAMAGE ANY WEB SITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES**

THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING SEEKING CRIMINAL PROSECUTION.
